Fenoxycarb	Award	"Pasture, Rangeland, Grazed Areas"	Yes	No	Can only be used on pasture, rangeland or grazed areas only if animals are not used for human consumption.
Indoxacarb	Advion	"Fenced Pastures"	Yes	No	Fenced pastures grazed only by companion animals.
Pyriproxyfen	Distance	"Non-grazed Pasture and Rangeland"	Yes	No	Non-grazed pasture and rangeland
Spinosad	Conserve		Yes	No	Do not graze livestock in treated areas. Do not feed treated grass cuttings to livestock or use hay for livestock bedding.
Hydramethylnon	Amdro	"Pastures and Rangeland"	Yes	No†	Grounds surrounding poultry houses (excluding runs and ranges), corrals and other animal holding areas. May be applied to pastures and rangeland if used only for companion animals that are not used for food or feed.
Carbaryl*	Sevin SL	"Forages or Feed"	Yes	Depends <sup>§</sup>	Sevin SL can be used in a drench but there are restrictions. Sevin can be applied to forages or feed for dairy or meat animals but the use restrictions are very strict about residues in crops, meat or milk (Do not apply within 7 days of harvest/grazing for forage).
Hydramethylnon	Amdro Pro	"Pastures and Rangeland"	Yes	Depends <sup>§</sup>	Do not cut and bale hay from pastures and rangeland treated with Amdro Pro until 7 days after the bait application is made. The cutting and baling hay restrictions do not apply when the treated pasture and rangeland is used solely to support companion animals (e.g. horses, llamas).
Methoprene + Hydramethylnon	Extinguish Plus	"Pastures and Rangeland"	Yes	Depends†, §, ¶	Grounds surrounding poultry houses (excluding runs and ranges), corrals and other animal holding areas. State restrictions for applications to grass forage (pastures and rangeland). Do not bale and cut treated pastures and rangelands for 7 days following application. The cutting and baling hay restrictions do not apply when the treated pasture and rangeland is used solely to support companion animals (e.g. horses, llamas).
Methoprene	Extinguish	"Pastures and Rangeland"	Yes	Yes	No withdrawal or grazing restrictions
Pyriproxyfen	Esteem	"Pasture Grass and Rangeland"	Yes	Yes	No withdrawal or grazing restrictions.
